**Marathon**

Station Name:            Directions:

"West State St."      From EMS Station 51:  
West Union Street to North Shafer then left on West State to access  
road between OU Driving Range and first of Jaycee Ball Fields on  
right across from Athens City Garage

"Armitage"            From EMS Station 51:  
West Union Street to SR 682 to Armitage Road.  
Proceed to end of Armitage Road near rail crossing

"Eclipse"              From EMS Station 51  
West Union Street to SR 682 to Johnson Road. Right on Johnson  
Road to right on Jackson Drive. Approx. 0.5 mile to Eclipse Store  
bikeway crossing.

"Lower River Rd"      From EMS Station 51:  
West Union Street to SR 682 to US 33  
To River Road (Athens Messenger end).  
Approx 1.5 miles up River Road on right.  
(At bikeway fence next to road)

"Upper River Rd"      From EMS Station 51:  
West Union Street to SR 682 past Rutland's to right on River Road  
Approx 0.3 miles in on River Road

"Hamley Run"         From EMS Station 51  
West Union Street to SR 682 past Rutland's to left on Hamley Run  
Road then bear right to continue on Hamley Run Rd (T-252)  
Proceed to end of Hamley Run road at 2nd Bikeway crossing

- "Glen Ebon"            From EMS Station 54:  
US 33 south to right on County Road 4. Approx 0.5 mile to bikeway
- "Monk Road"            From EMS Station 54:  
US 33 to SR 691.  
Left on Monk Road (T-271) just before Matheny Road (T-269).  
Proceed to end of Monk Road.
- "Turn Around"            From EMS Station 54:  
Right on SR 691 to left on Inn at Hocking College road before Tri-  
County. Follow to south side of Inn by training center addition and  
parking lot. Walking access to path. Turnaround approx 100 yards east on  
bikeway.
- "Start"                    From EMS Station 51  
West Union Street to College Street. Closer to start at  
8:00 AM, may have to take Shafer Street South to Richland Avenue  
to Court if blocked.
- "Finish"                  From EMS Station 51  
West Union Street to Shafer Street South to Pruitt Field on left across  
from Hospital Drive. Access to field near OU Food Service building  
and power plant.
