Media Submission to ARRL

Repeater

Jim Crouse reported that beginning about noon on Saturday, October 18 a continuous tone signal on the repeater input frequency. The repeater timed-out but Jim could still hear the signal at his house for about an hour. When the signal went away, the repeater came back up.
