Minutes of the meeting of September 17, 2013

Following the social gathering at 7:00pm the meeting was called to order at 7:30 pm by President Eric McFadden, WD8RIF.

Zach Holl, Board President of ReUse Industries, made a 30-minute presentation on ReUse Industries' upcoming Fix-It Workshops. Mr. Holl is looking for volunteers to help people repair electric/electronic devices at the Fix-It Workshops. Mr. Holl's hand-out describing the planned Workshops is available here in PDF format. In the absence of Secretary Hans Hake, KD8NLI, the minutes of the May, 2013 meeting were distributed by President Eric McFadden, WD8RIF. The minutes were accepted as distributed.

Treasurer Jim Crouse, KC8OVB, distributed the financial report. The club currently has \$1,863.27 in unencumbered funds. The Treasurer's report was accepted as distributed. Jim also reported that the ACARA received a thank-you card from the organizers of the Athens Marathon.

Old Business

ACARA 145.15 MHz Repeater

VHF Repeater Trustee Eric McFadden, WD8RIF, reported that he and Ted Jacobson, W8KVK, set up a listen-only EchoLink node to allow Eric to monitor the repeater in his office in the basement of Ohio University's Parks Hall. The node uses Eric's laptop computer and ICOM handheld transceiver and has since been relocated to the house of Jim Crouse, KC8OVB.

Eric McFadden reported that he visited the repeater site and removed Ted Jacobson's Ringo Ranger antenna from the rear of the building. Eric returned the antenna and one 10' section of mast to Ted. The second 10' section of mast was Eric's property. Ted had loaned the ACARA the antenna and mast while the club was trying to diagnose antenna/feedline performance issues.

Old Business (cont'd)

ACARA Linked 440MHz Repeater at Athens 9-1-1 Site

On behalf of UHF Repeater Trustee Jeff Slattery, N8SUZ, Eric McFadden reported that Jeff had met with Athens 9-1-1 Director Dan Pfeiffer on July 17. Jeff learned that the County will be installing a new MARCS system in the building and removing unneeded antennas and feedlines; he was told that the ACARA will need to remove unneeded items from the building and move the repeater equipment into a county-provided rack. Jeff also learned that Frontier will be installing new multi-line telephone cables; Jeff requested one pair be run to the UHF repeater.

Jeff and Eric visited the repeater site in August and moved the repeater into the county-provided rack and identified and labeled the ACARA's feedlines. They discovered inconsistencies in the original feedline labels and need to borrow a UHF-capable antenna analyzer to verify which antennas the feedlines are connected to. Bob Curtis, KD8FRQ, thinks his analyzer might cover the 440MHz band.

Currently, the UHF repeater utilizes a homebrew EPROM-based controller. Jeff would like to replace this with the ACARA's retired ACC RC-96 controller. Eric delivered the RC-96 controller and manual to Jeff.

Eric showed a photo of the repeater in its new rack.

APRS Digipeater

Eric McFadden reported that the digipeater currently is using a DCI Model 146-4H 4-pole bandpass filter that is the property of Ted Jacobson, W8KVK. This device is used to limit out-of-band RF energy at the site from reaching the digipeater's receiver. Ted would either like this device back or would like to sell it to the ACARA for \$175. The DCI Model 146-4H is currently available new for about \$400. John Biddle, W8PG, made a motion that the ACARA purchase Ted's DCI Model 146-4H filter for \$175; the motion was seconded by John McCutcheon, N8XWO, and the vote passed unanimously.

June Picnic – Thursday, June 20, 2013 at Dairy Lane Shelter House

Jim Crouse, KC8OVB, reported that the June Picnic was a fine picnic. Eric McFadden, WD8RIF, reported that attendance was lower than anticipated but the food was good.

Old Business (cont'd)

Field Day - June 22-23, 2013

Eric McFadden, WD8RIF, reported that the ACARA participated in class 1A and made 555 QSOs and earned 1050 bonus points for a score of 3092 points. Dan Pfeiffer and the Athens 9-1-1 center provided the 50' trailer-mounted tower which was used to support the HF antennas. Third Sun Solar provided their solar-demonstration trailer which was used to provide power to both the HF and VHF stations.
