## **Club Construction/Education Project**

One ballot included a comment: "I'd like to have some construction projects that a number of us could do together. These construction projects should include learning the theory behind the circuits being worked on." The suggestion was met with approval from the assembled members and discussion ensued over possible projects. Drew McDaniel, W8MHV, suggested the president appoint a committee to come up with ideas to present to the club at a later meeting. ## **ACARA Holiday Dinner**

Jim Crouse, KC8OVB, suggested it was time to determine a date and location for the ACARA Holiday Dinner. Jim reported that the 3<sup>rd</sup> Tuesday in December is the 17<sup>th</sup> which the assembled members agreed is probably a good date for the dinner.

Drew McDaniel, W8MHV, reported that Lui Lui has changed management. Eric McFadden, WD8RIF, will contact Lui Lui to see if the new management is interested in hosting the Holiday Dinner.

Drew McDaniel suggested Gigi's in The Plains might be willing to host the Holiday Dinner. He will contact them.

Eric McFadden reported that if neither Lui Lui nor Gigi's can host the Holiday Dinner, the Executive Committee will chose a venue and will notify the membership.

### Repair of APRS Digipeater Radio

Eric McFadden, WD8RIF, reported that Jeff Slattery, N8SUZ, had paid \$107.50 for the repair of the ailing ICOM IC-2100 that had been serving as the APRS and had submitted the bill to the club last month. Jeff had stated that if the club decided against reimbursing him for the repair, he'd be happy to keep the radio for his EMCOMM Go-Box.

Jim Crouse, KC8OVB, stated that the repair cost of the IC-2100 is over half the cost of purchasing a new IC-2300H.

Eric McFadden suggested four possible options:

- 1. Reimburse Jeff and club keeps radio; the club currently has three ICOM 2m mobile rigs in WD8RIF's garage.
- 2. Don't reimburse Jeff but sell him the "broken" radio at some nominal amount--\$30?
- 3. Reimburse Jeff and sell the repaired radio to a club member through a "silent auction" with the requirement that minimum bid be the cost of the repair.
- 4. Reimburse Jeff; give the radio away via random drawing after selling enough tickets to cover cost of repair. Eleven tickets at \$10/each would cover cost of the repair.

John McCutcheon, N8XWO, suggested a fifth option: sell the repaired radio at our hamfest.

# Repair of APRS Digipeater Radio (cont'd)

After much discussion, Carl Denbow, N8VZ, made the following motion that was seconded by Robert Moore, KC8KSM:

- The club reimburse Jeff \$107.50 for the repair of the radio;
- sell raffle tickets to club members at the price of \$10 per ticket;
- provided at least eleven tickets have been sold, award the radio to a club member by random drawing at the ACARA Holiday Dinner; and
- the winner need not be present at the ACARA Holiday Dinner to win.

The vote passed without dissent.

Eric McFadden and Jim Crouse will work out the logistics of creating and making available the raffle tickets. Eric will inform the club membership of availability of tickets as soon as they are available. Treasurer Jim Crouse will reimburse Jeff for the repair of the radio.

Carl Denbow, N8VZ, moved to adjourn the meeting; the motion was seconded by John McCutcheon, N8XWO. The vote passed without dissent. The meeting was adjourned by President Eric McFadden, WD8RIF at 8:53pm.
