Minutes of the meeting of November 19, 2013 - Amended

Following the social gathering at 7:00pm the meeting was called to order at 7:30 pm by President Eric McFadden, WD8RIF.

Program: The Wouxon X1M Transceiver, presented by Drew McDaniel, W8MHV.

In the absence of Secretary Jan Slattery, KD8PUJ, the minutes of the October 15, 2013 meeting were distributed by President Eric McFadden, WD8RIF. Bob Curtis, KD8FRQ, and Don Carter, KA8PJQ, each notified Eric of errors which Eric McFadden will fix. John McCutcheon, N8XWO, made a motion that the minutes be accepted as amended; the motion was seconded by Jim Crouse, KC8OVB. The vote passed without dissent.

Treasurer Jim Crouse, KC8OVB, distributed the financial report. The club currently has \$1,102.02 in unencumbered funds. John Thomas, KC8JWZ, moved that the report be accepted; the motion was seconded by Bob Moore, KC8KSM. The vote passed without dissent.

Old Business

ACARA 145.15 MHz Repeater

VHF Repeater Trustee Eric McFadden, WD8RIF, reported the repeater appears to be working well but that he needs to visit the site soon to perform winterization. He hopes to visit the repeater site the weekend of November 23-24.

ACARA Linked 440MHz Repeater at Athens 9-1-1 Site

UHF Repeater Trustee Jeff Slattery, N8SUZ, reported that the UHF repeater is performing well except for a possible intermittent receiver-sensitivity issue. Jeff is in the process of making the cables to allow use of the club's RC-96 repeater controller. Jeff is still trying to contact the builder of the repeater to determine exactly what antennas are on the tower. Jeff has been working on registering the repeater with the Ohio Repeater Council. Jeff reports that the MARCS system has not yet removed the unused antennas and feedlines from the tower.

Raffle of repaired IC-2100H APRS transceiver

Eric McFadden, WD8RIF, reported that as was decided at last month's meeting, the club will be giving away by raffle the club's repaired IC-2100H radio that had been used in APRS-node service. Eric confirmed with Treasurer Jim Crouse, KC8OVB, that Jeff Slattery has been reimbursed the cost of the repairs to the radio.

Antenna Party at Red Cross of Southeast Ohio (Athens County Chapter) – Saturday, November 2, 2013

Jeff Slattery, N8SUZ, made the following report:

Jeff Slattery, N8SUZ; Eric McFadden, WD8RIF; Kirk Groeneveld, KC8JRV; and Lance Groeneveld, KD8KMZ, all of ACARA, assisted three communications team members from the Red Cross of Central Ohio (Columbus Chapter) to erect a low band 6-meter VHF antenna on 47.42MHz for installation of a base radio capable of communicating with the local Emergency Response Vehicle (ERV) and other Red Cross vehicles on the National Red Cross frequency. The ERV is used to distribute food and cleanup supplies during a disaster. Also erected a second 2-meter AR2 Ringo to be used for secondary 2-meter voice or packet/APRS operations. This will probably be replaced later with a dual band Ringo AR270 or something similar. The Columbus Chapter is also working on getting an HF radio for Athens. Jeff plans to bring his Hustler 5BTV antenna from the high school to set up on the roof to use with this radio once it is arranged. Volunteer hour reported to ARRL: 16

ARRL Field Day (June 22-23, 2013) Results

Eric McFadden, WD8RIF, reported that the results of the 2013 ARRL Field Day are now available in the December issue of QST and online (link).

The ACARA made 555 QSOs and earned 3,092 points. This score earned the ACARA a 16th place in Class 1A out of 104 entries, a placement at the 16th percentile. The ACARA placed 2nd in Ohio in Class 1A and second in the Great Lakes Subdivision in Class 1A.

For comparison, in 2012 the ACARA placed 33rd in Class 1A out of 128 entries (26th percentile) and in 2011 the ACARA placed 35th in Class 1A out of 149 entries (23rd percentile.)

Club Construction / Education Project

Neither Drew McDaniel, W8MHV, nor Carl Denbow, N8VZ, were at the meeting so this topic was tabled until January. (Drew left the meeting early.)

New Business

ARRL 10-meter Contest – December 14-15, 2013

Greg Weinfurtner, NS8O, reported on the upcoming ARRL 10-meter Contest and encouraged all members to participate. The ACARA will be participating as a club and every submitted log helps even it that log contains only a few QSOs.

Greg distributed a primer on the ARRL 10-meter Contest; it is available in PDF format here.

Greg also displayed the *NC8V Memorial Trophy*. This rotating trophy goes annually to the ACARA member who earns the highest score in the ARRL 10-meter Contest.

Those participating must contact Eric McFadden, WD8RIF, after the event with their QSO-count and calculated score so he can supply a list of participants to the ARRL and so he can determine who will take home the *NC8V Memorial Trophy*. Participants are responsible for submitting their own logs to the ARRL; each log in Cabrillo format must include "ACARA" in the header.
