Corrections/Additions to Minutes

The minutes of the April 16, 2019 meeting were distributed. An error found in the Jim Crouse Memorial Radio Station plaque wording—the words "Amateur Radio" were repeated. Drew McDaniel, W8MHV, moved that the amended minutes be accepted. John Thomas, KC8JRZ, seconded the motion. The motion passed.

Treasurer's Report

Club Treasury

Treasurer Drew McDaniel, W8MHV, presented the Treasurer's Report. As of meeting-time on the 21st, the treasury had \$6,745.31 in unencumbered funds plus \$520.15 in the Jim Crouse Memorial Fund.

Athens Hamfest

Drew presented the Athens Hamfest financial report. The 2019 Hamfest brought in a total of \$1,494, of which \$842.14 is profit. Drew does not have numbers for 2018 but a comparison of numbers for 2019 and the years between 2012 and 2017 indicate a decline in attendance and a decline in income. Drew suggests the club investigate new marketing methods in addition to or instead of paper postcards. A suggestion was made that we send complimentary tickets to local clubs to give to their members.

Carl Denbow, N8VZ, reported on a conversation he had had with the principals of Debco at Hamvention. Debco sees a good profit from the Athens Hamfest and

will continue to come to our event. They will not, however, continue to attend the Jackson Hamfest.

Josh Cash, KE8EAS, suggested attendance at the Hamfest might be down due to Jackson Hamfest falling the day prior to our event and our event being on a Sunday. He suggested some vendors and other participants might be unable to attend on a Sunday.

Carl reported on a conversation he had had with Roy Moore, KB8ZSG, who has noticed that hamfest that occur on one of the first two weekends of a month are more profitable than hamfests that occur on one of the last two weekends of the month. This difference could be due to individuals on a fixed income or others who receive their pay earlier in the month. Drew suggested the club might consider changing the date of the Hamfest to the first weekend in May.

501(c)(3)

Drew reported he continues to work to reinstate the club's 501(c)(3) status. He has spoken with three attorneys, none of which were willing to help. Drew also spoke to an accounting firm, who also was similarly unwilling to help. Drew did find FAAS Accounting, who has a specialist for non-profit organizations, and who is willing to help. Drew thinks our 501(c)(3) status will be re-instated by midsummer.

Drew also reported that the ACARA has failed to file the required tax returns for the past three years. Drew will file the needed returns but suggested we will probably be required to pay penalties and back taxes.

Carl Denbow, N8VZ, made a motion that the Treasurer's Report be accepted. Bob Curtis, KD8FRQ, seconded the motion. The motion passed.

Old Business

VHF Repeater

VHF Repeater Trustee Eric McFadden, WD8RIF, reported via email that the repeater continues to operate as expected. He has attempted to contact J&M Wireless Services about our need for a climber but no reply has been received yet.

Carl Denbow, N8VZ, asked why digital-mode is not yet available on the 2m repeater.

UHF Repeater

UHF Repeater Trustee Jeff Slattery, N8SUZ, was not present at the meeting.

Bob Curtis, KD8FRQ, reported he has tested the repeater and he has been able to bring it up from his house.

Proposed DMR Repeater

Jeff Slattery, N8SUZ, was not present at the meeting; no report was provided.

Red Cross Radio Station / Jim Crouse Memorial Radio Station

Josh Cash, KE8EAS, reported he has sold the club's IC-718 transceiver to club-member Joe Weber, KE8LRZ; the proceeds from this sale will be applied to the Jim Crouse Memorial Fund and this will be reflected in next month's Treasurer's Report. Josh has listed the FL-53A CW filter on QRZ.com and will also list it on QTH.com.

Drew McDaniel, W8MHV, reported he had looked for an Elecraft K3 transceiver at Hamvention the previous weekend and had found two. One was being offered at "new" price of \$1,800. The other included the second receiver and a full set of filters and was being offered at a price over \$2,000. Both transceivers are out of the club's price-range at this time.

Drew again brought up the idea of providing solar-electric back-up power for the station. He suggested something as small as a 100-watt photovoltaic panel and a battery bank would be enough for an emergency situation. This discussion was tabled pending purchase of a new transceiver and re-instatement of the club's 501(c)(3) status.
