
Pre-Meeting Show-and-Tell

In the photo, the spectrum analyzer software is looking at the entire 2m ham band; the tall spike is a signal on 146.400 MHz being generated by a nearby HT.

Pre-Meeting Announcement

Eric McFadden, WD8RIF, announced that an *Amateur Radio on the International Space Station* (ARISS, https://www.ariss.org/) QSO is scheduled with Maple Dale High School in Cincinnati on February 20, 2020. The QSO will start at 18:20:28 UTC and will last for about seven minutes. The transmissions from astronaut Drew Morgan on the ISS will be able to be heard over all of southeastern Ohio for most of the pass. The ISS's downlink frequency is 145.800 MHz; to account for Doppler Shift due to the ISS's high speed in Low Earth Orbit, begin listening on 145.805 MHz, switch to 145.800 MHz mid-way through the pass, and finally switch to 145.795 toward the end of the pass. The ISS will be at 314.5° as it initially climbs above the horizon, will be at 34.8° azimuth and 58.7° elevation at its highest point in the middle of the pass, and will be at 116.2° when it finally drops again below the horizon.

Treasurer's Report

Treasurer Drew McDaniel, W8MHV, distributed the Treasurer's Report. The report showed that the club treasury holds \$3999.22 in unencumbered funds and that the *Jim Crouse Memorial Fund* holds \$50.30.

Drew reported that he has sent out membership renewal reminders via post using club membership rosters going back to 2016. As of the meeting date, Drew's postal campaign has netted four membership renewals.

Drew reported he has been analyzing the club's membership. The club had 35 paid members in 2015, and 25 paid members in 2019. Currently, the club has 24 paid members but this number is expected to grow as a result of Drew's postal campaign.

Drew reported that he has paid the club's liability insurance but, as with the club's equipment insurance, Mercer failed to process the renewal in a timely fashion and Drew was forced to submit an application for a new policy. As decided during the January meeting, next cycle, Drew will purchase insurance through the ARRL's program.

Drew reported that the *Jim Crouse Memorial Radio Station Sustainable Funding Task Force* consisting of himself; Carl Denbow, N8VZ; and Bob Curtis, KD8FRQ, has not yet been able to meet because of scheduling conflicts. Drew hopes the Task Force can meet this coming Saturday.

Bob Moore, KC8KSM, moved that the Treasurer's Report be accepted as presented. The motion was seconded by Bob Curtis, KD8FRQ. The motion passed without dissent.

Old Business

VHF System Fusion Repeater

VHF Repeater Trustee Eric McFadden, WD8RIF, reported that the 2m DR-2X System Fusion Repeater continues to function properly.

Jeff Slattery, N8SUZ, reported via email that the 9-1-1 Center's Brian Davis will be leaving the area in April and suggested the ACARA should move the repeater antenna to the 9-1-1 tower prior to the departure of Mr. Davis.

UHF System Fusion Repeater

UHF Repeater Trustee Jeff Slattery, N8SUZ, reported via email that the 70cm DR-2X System Fusion Repeater appears to be functioning properly and that the repeater coordination with the Ohio Area Repeater Council (OARC) has been updated.

VHF DMR Repeater

Drew McDaniel, W8MHV, expressed surprise that the proposed DMR repeater will be on 2m since the majority of ACARA members who own DMR equipment have UHF-only DMR equipment.

Athens EMA Radio Station

Jeff Slattery, N8SUZ, reported via email that he began discussions with Athens EMA Director Don Gossell about upgrades to the radio station at the Athens County EMA. Jeff presented a wish-list and quote from GigaParts to Mr Gossell for an ICOM IC-7300 HF transceiver, a Hustler 6-BTV vertical HF antenna, an HF multi-band fan-dipole, an LDG AT-100Proll antenna tuner with ICOM-specific interface cable; an Alinco DR-735T 2m/70cm FM transceiver, a 2m/70cm base-station antenna, Polyphaser lightning arrestors, and feedlines. Mr Gossell approved the purchase of all these items through an Emergency Management Performance Grant (EMPG). We may need to come up with a side-arm mount for the fan dipole but there are existing mounts for everything else.

Jeff believes Mr Gossell will be ordering prior to March 1. The equipment will belong to EMA and will be insured by the county. We will be under an MOU for operating drills and declarations.

Drew McDaniel, W8MHV, asked if the Athens County EMA has emergency back-up power. No one present knew the answer to this question.
