## VHF and UHF Repeaters

Eric McFadden, WD8RIF, reported that the VHF repeater seems to have an intermittent sensitivity issue—it acts like the receiver is being desensed by another signal. Eric asked that we watch for patterns during the weekly 2m Net and, perhaps, use a spectrum analyzer or broadband receiver to identify the signal.

Jeff Slattery, N8SUZ, reported that the Athens County EMA EMS VHF alerting frequency has been changed to 154.1675 MHz and suggested this might be the signal causing the desense. He will monitor the VHF alerting frequency during the 2m Nets to see if transmissions on correspond with periods of desense. (Correction: "EMS", not "EMA".)

Jeff Slattery reported that the UHF repeater appears to be working properly in both FM and System Fusion modes.

Jeff Slattery reported that he is continuing to work with the Arcom RC-210 Repeater Controller. He has been working with the manufacturer to identify internal switches and configurations to complete the interface to a Yaesu DR-2X repeater. Jeff has found the owner of Arcom, Ken Arc, to be very helpful and he has been impressed with the support he has received.
