ACARA operating as W8UKE was the only park-activator to earn a "Golden Log" distinction for no errors in log.

N8SUZ/R placed 3rd out of 5 in class *Rover* with 768 points.

In 2020, four members submitted their logs for a total of 15,600 points and 9th place out of 15 in Category *Local*.

Second, within the ACARA, the ACARA member submitting the highest score to ARRL wins the right to hold the coveted NC8V Memorial Trophy for a year.
