Old Business

VHF and UHF Repeaters

VHF Repeater Trustee Eric McFadden, WD8RIF, reported that he visited the repeater site on November 3 to participate in the ACARA Monthly 2m Simplex Net. Using the repeater's antenna and feedline and an IC-2100H transceiver, Eric was able to hear all stations participating in the net. All stations drove his transceiver's S-meter to full-scale. All stations except the out-of-county stations and a mobile station near Nelsonville were full-quieting. Eric takes this as an indication that the repeater antenna and feedline remain in good condition. While on-site, Eric checked the tightness of all antenna and duplexer connections. Since this visit, the repeater has not shown signs of intermittent insensitivity and it's possible that tightning the connections fixed an intermittent poor connection.

UHF Repeater Trustee Jeff Slattery, N8SUZ, reported that the 70cm repeater continues to functioning well in both analog FM and C4FM System Fusion modes.

ACARA Nets

Eric McFadden, WD8RIF, reported that the ACARA's weekly and monthly nets continue to do well. He reminded members of the current net schedule:

Eric reported that members will receive an email concerning the selection of a new day-of-the-week and time-of-day for the 10m SSB Ragchew Net.

Officer Elections

Eric McFadden, WD8RIF, reported that following last month's meeting, which had low turn-out, and at which the only nominations for officers were for incumbents, he built and distributed a Qualtrics survey to paid members asking for club-officer nominations. Only one new nomination received, a nomination for Ted Jacobson, W8KVK, for Treasurer; Ted is not an ACARA member and this nomination was discarded.

Eric reported that using Qualtrics, he built and distributed an electronic ballot to paid members, with a deadline of midnight, November 14. After the ballots closed, and after seven blank ballots were removed, seventeen valid ballots remained.

Club Building Projects.

Eric McFadden, WD8RIF, reminded the membership that the build-leaders will contact those who have expressed interest in their projects and will schedule the build-sessions. Eric explained that now that winter weather has arrived, the projects that require sweating copper pipe (J-pole, "Mighty Woof") will need to wait until Spring—we don't want to be dripping solder or hot flux on the carpet in the Red Cross chapter house.

Eric reminded the membership of the upcoming club building projects:

- Jeff Slattery, N8SUZ, will lead a build-session for a collapsible copper 2m J-pole antenna
- Kirk Groeneveld, KC8JRV, will lead a build-session for a copper 2m dipole called the "Mighty Woof"
- Paul Schulz, WD8SCV, will lead a build-session for an HF end-fed halfwave antenna
- Drew McDaniel, W8MHV, will lead a build-session for a two-band HF trap-dipole antenna

Eric reported that the foxhunt offset attenuator group-buy led by Kirk Groeneveld, KC8JRV, has been completed.

ARRL Foundation Club Grant

Eric McFadden, WD8RIF, reported as background that the ARRL Foundation, funded by a grant from ARDC, is making available \$500,000 to radio clubs. The program will provide up to \$25,000 for worthy club projects. For the first round, the ACARA Executive Committee built a grant-proposal to fund significant upgrades to the Jim Crouse Memorial Radio Station to include the purchase a high-performance HF transceiver, a tower, and an HF beam antenna. The ACARA's proposal in the first round was not awarded a grant.

Eric reported that the second round of the grant is now underway. The ACARA Executive Committee has extensively re-written the club's grant-proposal, strengthening the justifications for the request, and the final package was submitted on November 2, prior to the November 4 deadline. ACARA will learn in January if this grant proposal was successful.

Eric reported that because the grant-proposal involves erecting a tower on the grounds of the Red Cross chapter house, a Memorandum of Understanding (MOU) between the ACARA and the Red Cross is needed. On November 9, Jeff Slattery, N8SUZ, forwarded the final draft of the MOU as delivered by the Red Cross to the members of the Executive Committee. The Executive Committee is still studying the document, but it has already been determined that the Red Cross will require ACARA to carry liability insurance. Eric has asked Treasurer Drew McDaniel, W8MHV, to investigate the cost of liability insurance.

ARDC Grant

Eric McFadden, WD8RIF, reported that the ACARA Executive Committee has not yet met to discuss a grant proposal to ARDC but he suggested that if the ACARA were to fail receiving a grant in the second round of the ARRL Foundation Club Grant, the club could apply for an ARDC grant for the project.

Results: Ohio State Parks on the Air (OSPOTA)

Eric McFadden, WD8RIF, reported that results from 2022 Ohio State Parks on the Air (OSPOTA) have been published on the OSPOTA website.

After all the participating stations' logs were cross-checked, the ACARA operating as W8UKE ended up placing fourth in class "Multi Op, Single Radio, Low Power, in a Park" with 12,100 points. The winning station inclass was Preble Amateur Radio Association, operating as N8XC at Hueston Woods State Park, with 19,080 points. Second place in-class was Portage County Amateur Radio Association, operating as AD8FQ at Wingfoot Lake State Park, with 6,390 points. Third place in-class was N8EU, operating at John Bryan State Park, with 14,448 points.

Sunday Creek Amateur Radio Federation (SCARF), operating as KC8AAV at Burr Oak State Park, placed first in class "Multi Op, Single Radio, High Power, in a Park" with 23,691 points.

Sixty of Ohio's seventy state parks were activated. Of these, five parks were activated but no logs were submitted.

Results: ARRL Field Day - June 25-26, 2022

Eric McFadden, WD8RIF, reported that Field Day 2022 results have been published in the December 2022 issue of QST magazine. ACARA placed 21st out of 131 in Class 1A, which places the club in the top 16%. Within Class 1A, ACARA placed 2nd in Ohio, 2nd in the 8th call-district, and 3rd in the ARRL Great Lakes Subdivision (OH, MI, KY).

Eric reported that since last month's meeting, he has visited Stevens on Court (https://stephens66.com/) twice but hasn't yet heard back from the manager/owner. Stevens on Court typically closes over the winter break, so it's likely the venue won't be available for our event.

Eric reported that he and his wife took dinner at Cirò Italian Kitchen and Bar (https://ciroinathens.com/) on West Union. The food was very good, but the venue is small and it might not accommodate our event well.

Eric said he will investigate Zoë Fine Dining (http://www.zoefinefood.com/).

Eric asked for additional suggestions. John McCutcheon, N8XWO, said he thought last year's venue, Pizza Cottage (https://www.pizza-cottage.com/) on East State Street, worked well, and he also suggested we consider Albany Cafe (https://albanycafe.com/). Jeff Slattery, N8SUZ, said he thinks the Lawrence County club is the only Special Service Club in our ARRL district.

Operating Event: Foxhunts

Kirk Groeneveld, KC8JRV, reported that ACARA held two foxhunts in 2022. He said that participants were passionate and had fun participating in the events. He added that, now that winter weather has arrived, it's unlikely that the club will sponsor another foxhunt this year.

Kirk suggested that after the return of warmer weather the club might hold a "work session" type of foxhunt in a local park, where participants can learn to use their directional antennas and other direction-finding equipment to find hidden low-power transmitters.
