Old Business

VHF and UHF Repeaters

VHF Repeater Trustee Eric McFadden, WD8RIF, reported that the 2m repeater is operating normally. He has not recently noticed any periods of desense, but added that because of the ACARA Technician license classes, he has been unable to participate in the weekly 2m FM nets.

Eric reported that he has not heard back from Wilmington-based Paul Jellison, K8IO, about testing and tuning our cavties. Eric reminded the members that last month Drew McDaniel, W8MHV, had mentioned that he now has a spectrum analyzer and can verify the tuning of the cavities.

Eric reported that the UHF repeater is also operating normally.

Club Building Projects.
