Corrections/Additions to Minutes

A motion to accept the February minutes as published was made by Paul Schulz, WD8SCV. The motion was seconded by John Biddle, W8PG. The motion passed without dissent.

Treasurer's Report

In the absence of Treasurer Drew McDaniel, W8MHV, the Treasurer's Report was presented by President Eric McFadden, WD8RIF. After a deposit of \$170 from incoming membership dues, the club treasury holds \$1,449.46 in unencumbered funds. The *Jim Crouse Memorial Fund* holds \$48.25.

Old Business

VHF and UHF Repeaters

VHF Repeater Trustee Eric McFadden, WD8RIF, reported that the 2m repeater is operating normally. He has not recently noticed any periods of desense, but added that because of the ACARA Technician license classes, he has been unable to regularly participate in the weekly 2m FM nets. Michael Baxla, KE8ICP, did report there had been sensitivity issues during a recent ACARA Weekly 2m Net.

Eric reported that Paul Jellison, K8IO, contacted Jeff Slattery, N8SUZ, about testing and tuning our cavities. Eric will contact Mr. Jellison by telephone. Eric reminded the members that in January Drew McDaniel, W8MHV, had mentioned that he now has a spectrum analyzer and can verify the tuning of the cavities.

Eric reported that the 2m repeater is in dire need of a 70cm antenna to allow off-site control of the repeater. He explained that the Yaesu DR-2X repeater has a second receiver available for off-site control. Eric wants to configure this second receiver for 70cm and install an appropriate antenna so that he and other designated control operators can control the repeater remotely.

Eric reported that the UHF repeater is operating normally.

ACARA Nets

Club Building Projects

Eric McFadden, WD8RIF, reported that the end-fed halfwave antenna (EFHW) build to be led by Paul Schulz, WD8SCV, has been scheduled to take place at 2pm on Sunday, March 26 at the Red Cross of Southeastern Ohio. The EFHW, when cut for resonance on 40m, should allow for notuner operation on 40, 20, 10, and perhaps 15m. The cost for the EFHW matching unit kit is \$40; for an additional \$10, Paul will also provide 67' of antenna wire, a wire-winder, and an end-insulator. Paul reported that he has two EFHW kits still available. The club will provide all the tools necessary to build and adjust the EFHW at the build session on the 26th.

Eric reminded the membership of the other upcoming club building projects:

- Jeff Slattery, N8SUZ, will lead a build-session for a collapsible copper 2m J-pole antenna
- Kirk Groeneveld, KC8JRV, will lead a build-session for a copper 2m dipole called the "Mighty Woof"
- Drew McDaniel, W8MHV, will lead a build-session for a two-band HF trap-dipole antenna

Eric reminded the membership that the projects that require sweating of copper pipe (the J-pole, the "Mighty Woof") will need to wait until the arrival of Spring weather because we will need to do the copper-sweating outdoors.

Drew will not be able to lead his build of the two-band HF trap-dipole until sometime after early April.

Jim Crouse Memorial Radio Station

Eric McFadden, WD8RIF, reminded the members that the club's Elecraft K3 transceiver now has the optional KAT3 internal automatic antenna tuner and that, after the installation of the KAT3, the K3 showed signs of intermittent apparent antenna disconnection.

Eric reported that he currently has the K3 at his home station and has been testing it. He has heard the apparent antenna disconnection only once since its initial appearance in January. Eric will continue to to test the K3 and will ask Drew McDaniel, W8MHV, to further test the transceiver upon his return.

(Post-meeting update: Gerald Carter is now KE8WWF; Bob Weber is now KE8WWG.)

ARDC Grant

Eric McFadden, WD8RIF, reported that Ted Jacobson, W8KVK, had sent him the link to a page describing the Amateur Radio Digital Communications (ARDC) grants awarded in 2022: https://www.ardc.net/apply/grants/2022-grants/.

As background, Eric read the ARDC website's description of the grant program:

ARDC makes grants to projects and organizations that are experimenting with new ways to advance both amateur radio and digital communication science. Experimentation by amateur radio operators has benefited society in many ways, including the development of the mobile phone and wireless internet technology.

Eric reported that the ACARA Executive Committee will study the ARDC grant program and the list of the grants awarded in 2022 to determine if ACARA can qualify for a grant to upgrade the Jim Crouse Memorial Radio Station or other projects.

MESH in Athens County

Eric McFadden, WD8RIF, reported that Ted Jacobson, W8KVK, asked if there's interest in the ACARA to build out a Mesh network in Athens County, perhaps with ARDC grant-funding.
