#### **Corrections/Additions to Minutes**

# Treasurer's Report

The Treasurer's Report was presented by Treasurer Drew McDaniel, W8MHV. Reflecting expenses relating to the upcoming hamfest and the VHF repeater, and reflecting income from membership dues and a donation from the Athens Marathon Committee, the club treasury holds \$30,927 in unencumbered funds. The *Jim Crouse Memorial Fund* holds \$69.25.

A motion to accept the Treasurer's Report was made by John McCutcheon, N8XWO. The motion was seconded by Carl Denbow, N8VZ. The motion passed without dissent.

#### **New Business**

Athens Marathon Committee Donation to ACARA

Following the Treasurer's Report, President Eric McFadden, WD8RIF, announced that the outgoing Athens Marathon Committee has made an unsolicited \$30,000 donation to ACARA.

Eric received the check from Lisa Simons on April 15 and delivered it to Treasurer Drew McDaniel that same day.

Much discussion ensued about the donation and possible uses for the money. Three motions were made and voted on:

- Carl Denbow, N8VZ, moved that the ACARA purchase an ICOM IC-7610 for the Jim Crouse Memorial Radio Station and that the Treasurer be authorized to make the purchase of the transceiver and any accessories he deems necessary. This motion was seconded by John McCutcheon, N8XWO. The motion passed without dissent.
- Drew McDaniel, W8MHV, moved that a planning group be identified to create a plan for the disposition of the donation funds, and that this group should be representative of the interests of the members within the club. This motion was seconded by John McCutcheon, N8XWO. The motion passed without dissent.
- Carl Denbow, N8VZ, made a motion that the ACARA Executive Committee be directed to place \$25,000 of the donation into an account that pays significant interest while still allowing the money to be readily accessible The motion was seconded by Tony Perric, KE8VFA. The motion passed without dissent.

#### Old Business

# VHF Repeater

VHF Repeater Trustee Eric McFadden, WD8RIF, reported that on April 10, 2023, he took the 2m repeater cavities/duplexer to Wilmington, Ohio, where Paul Jellison, K8IO, realigned them using a professional-grade service monitor and decades of experience. After the realigment, Mr. Jellison was able to measure at least 105dB of rejection through each side of the cavities, 105dB being the limit of his instrument's ability to measure. Eric added the Mr. Jellison also verified proper operation of the repeater's additional 2m bandpass filter and coaxial interconnecting cables. Mr. Jellison demonstrated that the longer coaxial cables that are used to connect the cavities to the repeater are not well shielded and he suggested these be replaced with ½" Heliax cables.

Eric reported that when he reinstalled the cavities on April 11, he found that the 35-watt VOCOM amplifier appeared to be non-functional. He explained that this amplifier was initially purchased for use with the club's previous Yaesu analog FM repeater, which generates an 8-watt output signal; the amplifier is calibrated to generate a 35-watt output signal with an 8-watt input signal. With the current Yaesu DR-2X repeater, we had been running the repeater at 5-watts output into the VOCOM amplifier to produce a signal somewhat lower than 35 watts. The amplifier appearing to be non-functional, Eric removed it from the circuit and configured the DR-2X System Fusion repeater for its mid-level power output of 20 watts.

Eric reported that for the Athens Marathon, he configured the DR-2X System Fusion repeater to transmit in analog FM mode for both analog FM input and C4FM digital-voice input. He said he will restore the repeater to full AMS System Fusion functionality soon.

Eric reported that the repeater appears to work very well during ACARA support of the April 16, 2023, Athens Marathon. He noticed no instances of reduced sensitivity, and no operators had trouble hitting the repeater except in the few locations along the marathon course where one would expect repeater coverage to be poor. Even the operators at the Monk Run aid station were able to hit the repeater well with handheld transceivers.

Eric reported that the repeater worked very well during the April 17, 2023, 2m FM Net. Kenny Brooks, N8TWU, in Meigs County, was full-quieting into the repeater with his transmitter set at 5 watts. Similarly, Constantine Faller, KC8JXA, in Broadwell, was full-quieting into the repeater with his transmitter set at 5 watts.

## **UHF** Repeater

Eric reported that the UHF repeater continues to operate as well as it has been operating.

## Potential DMR Repeater

Carl Denbow, N8VZ, asked if Jeff Slattery,N8SUZ, is still considering deployment of a DMR repeater. Jeff answered that, yes, he is still considering deployment of a VHF DMR repeater.

### **ACARA Nets**

In the interest of time, Eric McFadden, WD8RIF, did not read the list of ACARA's weekly and monthly nets during the meeting.

Eric asks all members to participate in the ACARA weekly 2m FM net as we continue to test the repeater following realignment of the cavities.

# Club Building Projects

Eric McFadden, WD8RIF, reported that the end-fed halfwave antenna (EFHW) build, led by Paul Schulz, WD8SCV, took place at 2pm on Sunday, March 26 at the Red Cross of Southeastern Ohio. The build itself went well but when it came time to cut wire radiator to length outside, an unidentified RF-source prevented use of an antenna analyzer to trim the radiator for low SWR. The team tried two antenna analyzers and even a known-good antenna. Paul will schedule a session at his RF-quiet property for builders to trim their radiators for low SWR.

Eric reported that bicycle-mobile APRS tracking of the full-marathon male and full-marathon female lead runners worked well except those packets generated near Nelsonville failed to reach the iGate located at the Red Cross of Southeastern Ohio. He and Jeff Slattery, N8SUZ, think the PROTO PATH parameter of "WIDE1-1" programmed into the trackers didn't allow enough hops for the packets to reach the iGate via the digipeaters of Robin Kinney, KG6DI, at Glen Ebon Road and Carl Denbow, N8VZ, at the full-marathon turn-around.

Eric reported that Kat Wolf, KE8EAP, was to have served as pedestrianmobile "taillight" operator following the last runner in from the Hamley Run aid station. However, an approaching storm forced the event organizers to close the course early and SAG the slowest runner off of the course, so she didn't get to complete her walk. Carl added that the issue he encountered was that it's impossible to renew a club callsign online at FCC.gov, despite the website providing no indication of this. He eventually learned that one has to contact ARRL to start the process of renewing a club callsign.
